ABOUT THE GLOBAL INITIATIVE FOR JUSTICE, TRUTH AND RECONCILIATION

Around the world, there is an urgent need for justice, truth and reconciliation in countries where legacies of gross human rights violations cast a shadow on transitions from repressive regimes to participatory and democratic forms of governance. To date, however, many transitional justice models have failed to actively involve local voices—particularly marginalized groups such as women and survivors—which are crucial to ensuring a secure and peaceful future.

To rectify this gap, the Global Initiative for Justice, Truth and Reconciliation (GIJTR)—led by the International Coalition of Sites of Conscience (ICSC), a global network of museums, historic sites, memorials and memory initiatives that uses the past to address human rights today—offers holistic, integrative and multidisciplinary approaches to issues of truth, justice and reconciliation. A consortium of nine international organizations, GIJTR works with local populations, civil society organizations (CSOs) and governments to develop context-specific transitional justice approaches that are victim-centered, collaborative and support dignity, respect, inclusion and transparency in societies emerging from conflict or periods of authoritarian rule.

Geographically and programmatically diverse, GIJTR partners develop and implement a range of rapid-response and high impact program activities, utilizing restorative and retributive approaches to justice and accountability for gross human rights violations.



The expertise of the organizations in GIJTR includes:

- truth-telling, reconciliation, memorialization and other forms of historical memory;
- documenting human rights abuses for transitional justice purposes;
- forensic analysis and other efforts related to missing and disappeared persons;
- victims' advocacy such as improving access to justice, psychosocial support and trauma mitigation activities;
- providing technical assistance to and building the capacity of civil society actors and organizations to promote and engage on transitional justice processes;
- reparative justice initiatives; and
- ensuring gender justice in all these processes.

In its first decade, GIJTR has engaged over 800 local CSOs in 80 countries; supported over 500 community-driven projects; produced 50 publications and resources; and facilitated the collection of more than 8,000 narratives of human rights violations.

ABOUT THIS EVENT

In celebration of the tenth anniversary of the Global Initiative for Justice, Truth and Reconciliation, this gathering brings together over 90 representatives, including GIJTR Consortium partners, local partners,

survivors, policy makers, donors and civil society representatives, to reflect on GIJTR's impact within its first ten years. Through addresses, panel discussions and interactive sessions, participants will share best practices and lessons learned as well as identify policy recommendations for ensuring that future transitional justice processes are as contextinformed, locally driven, non-prescriptive and victimcentered as possible. Held in partnership with the General **Directorate of Democratic**

Memory, the event—like all GIJTR gatherings—serves above all as a platform for connection and collaboration among survivors, civil society representatives and policy makers. The General Directorate of Democratic Memory of the Ministry of Justice, Rights and Memory works for the recovery of memory by promoting the relationship with memorialist institutions from all over the world; organizing activities related to the recovery of democratic memory; calling for grants for the recovery of memorial heritage, scientific research and dissemination in the field of memory: promoting the location of missing persons during the Civil War and the Franco regime; locating the existing mass graves in Catalonia; managing the compensations to former political prisoners of the Franco regime, and advising the people who were retaliated against.

This General Directorate manages and coordinates the relationship of the Generalitat of Catalonia (Government of Catalonia) with the Democratic Memorial (an ICSC member), the Exile Memorial Museum Consortium (MUME) and the Ebro Battle Areas Memorial Consortium (COMEBE).

CENTERING COMMUNITIES, AN EXHIBITION

Reflecting on a Decade of Innovative Approaches and Tools for Transformation

Over the last decade, the Global Initiative for Justice, Truth and Reconciliation (GIJTR) has transformed the transitional justice field by amplifying victims' voices and solidifying the participation of survivors, families and local communities in formal and informal transitional justice processes. Core to this transformation has been GIJTR's use of a multi-disciplinary approach that draws on different modalities of engagement, expression and awareness raising for a multitude of actors in conflict and post-conflict settings.

GIJTR strives to expand the conceptual and operational boundaries of the transitional justice field by locating communities at the center of its work. In learning new methods and definitions of achieving transitional justice, GIJTR has become a pioneer of innovative approaches to engaging with human rights violations and in so doing challenges established transitional justice practices to continue to grow and evolve. This is affirmed by innovative practice in multiple areas, including: memorialization as a fifth pillar of transitional justice; transitional justice and atrocity prevention; developing new frontiers in the documentation of human rights violations;

mainstreaming psychosocial support in transitional justice; and seeing art as a tool of transitional justice.

Through this exhibition, the depth and breadth of GIJTR's work is illustrated across a decade of working in multiple countries, with different communities, each grappling with legacies of human rights violations. Each item on display represents multiple deep and trusted connections held by GIJTR through relationship building with civil society and community-based organizations.

We invite you to experience the momentum of GIJTR's work across 10 years, as captured in the body maps that tell the life stories of survivors and paintings that illustrate their hopes for a peaceful future. This is accompanied by a host of digital materials, publications, videos, podcasts and art-based documentation methods from across a number of GIJTR projects.

Through each exhibition node, we invite you to read, reflect and dialogue with fellow exhibition goers. We ask you to observe the connections between the significance of preserving the stories from
